Sl.No	Query	Decision
1	M/s. Garware Wall Ropes raised a query that their fresh issue pending for some reasons	JDG informed that their fresh issue was kept pending for want of closure of old pending cases since it is verified and found that they have submitted documents in earlier pending cases, now the issue of fresh licenses will be considered.
2	M/s. Sudarshan Chemical raised a query about removal of DEL List	JDG informed them that since there were some cases in the REIC meeting regarding DEPB issue, after clearance from REIC only their case will be finalized and after that only their name will be removed from DEL List.
3	M/s. Techno Force Solutions India Pvt.Ltd sought clarification on the point of refixing their average export performance after taking in to consideration of deemed exports made by them	JDG asked them to submit the required documents for re-fixation of average export performance and also discussed the matter with the concerned dealing assistant.
