Alicon Castalloy Ltd., representative raised a query that one of their unit they have merged with other unit and virtue of High Court has given to this office	JDG informed them that in the decision of High Court this office name has not been added as respondent in order to bring the FT (DR) Act in the judgement. Hence this office is not agreeable for the merger.
2	M/s. Deepak Nitrite Ltd, representative raised a query about removal from DEL List	JDG informed them that file is under process and will be removed once approved.
3	M/s. Sudarshan Chemical representative raised a query about removal of DEL List	JDG informed them that since there were some cases in the REIC meeting regarding DEPB issue, after clearance from REIC only their case will be finalized and after that only their name will be removed from DEL List.
4	M/s. RA India representative raised a query regarding their pending files of MEIS and VKGUY submitted on 05/10/2016.	<ol style="list-style-type: none"> <li>1. Regarding their pending MEIS, JDG informed them that in their MEIS file, description does not match so it got rejected. Description mis- match in MEIS cannot be considered for issue.</li> <li>2. Regarding their pending VKGUY, JDG informed them that VKGUY is only meant for agro products but their VKGUY application shows some other category not agro products. JDG instructed Section to process the case accordingly.</li> </ol>

Nirmal Impex representative raised a query regarding IEC amendment but not having digital key and from where to get the digital key	JDG informed him that without digital key they cannot able to amend the IEC. In dgftpune.nic.in, we have provided in "INFORMATION", in green color, there are 3 franchises of digital key is given, they can purchase from them.

JDG informed them that based on the DRI reply, the case will be decided upon.</li> <li>2. As regards, amendment sought by the representative it is informed that there is no provision in the policy and procedures for making any amendment in the EPCG Licence, This point also confirmed by Hqrs. and requested the representative to take-up the matter with Hqrs EPCG Committee.</li> </ol>
7	M/s. Atlas Copco representative raised a query regarding their one advance licence in DEL list.	JDG informed them that to check-up with Section about their DEL status and do the needful. After verification, it is informed to the representative that they have been put on a DEL by Additional Director General of Foreign Trade Mumbai office and requested him to approach that office for removal from DEL List.
8	M/s. Alcomex Springs Pvt. Ltd., representative raised a query regarding redemption of advance licence.	JDG informed that the Section will verify and if any mistake in the excess imports notified that will be reconsidered.
